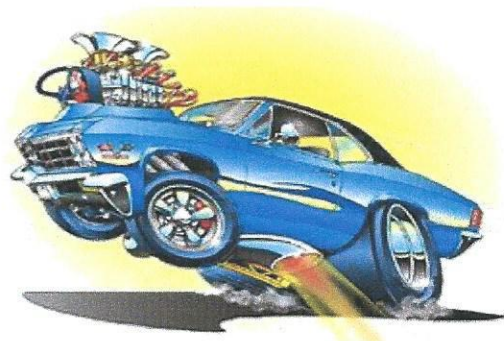

Please read the terms and conditions on page two of this permit. If you agree to all terms and conditions, sign and return the permit with required payment of \$100 per event per day, and copies of your NYS Liquor Authority License, NYS Health Department Certification and Certificate of Insurance to the Tiorati Beach office. Your approved permit will be mailed to you.

Catering/alcohol permits will be issued only after all other necessary permits have been issued.

This permit is not valid until signed by both the applicant and a representative of NYS OPRHP/PIPC.

Terms and Conditions:

- 1) This permit will be issued only to a bona fide group, club or business with a legitimate purpose.
- 2) This permit must be used only by the designated permittee and only for the location, date and time period stated.
- 3) Catering is limited to food and beverage service. All other activities must have prior approval from the facility manager.
- 4) Sale of food and beverages is not permitted under this permit.
- 5) Use of Styrofoam containers is not permitted.
- 6) All refuse and other waste products resulting from the activity must be properly disposed of. Washing of pots, pans and other utensils is not permitted.
- 7) This permit does not constitute a waiver of any applicable vehicle use fees which must be paid at the point of entry. Vehicles must be parked in designated areas. No reserved parking spaces will be assigned.
- 8) Alcoholic beverages may be served only if the following conditions are met.
  - a) The permittee must use only a NYS Liquor Authority licensed dispenser.
  - b) A valid copy of the dispenser's license must be on display at the event and a valid copy must be returned with the signed permit application.
  - c) An alcohol dispensing agent must be the only person dispensing alcoholic beverages and only to those persons 21 years of age and older.
  - d) A "bar" must be established and, once established, no other place can be used for that purpose.
  - e) Alcohol must be poured into plastic or paper cups with no individual cans, bottles or Styrofoam containers being used.
- 9) A Health Department permit is required for all food preparation.
- 10) This permit is issued with the understanding that the person(s) or organization named above will comply with all Park rules and regulations as well as with the terms and conditions stated in this permit. Failure to do so may result in revocation of this permit and denial of future permits.
- 11) A copy of a Certificate of Insurance covering the contracted activity in the amount of \$500,000 for liability and property damage, and \$1,000,000 for product liability must be provided and name as ADDITIONAL INSURED: The People of the State of New York, the New York State Executive Department, the New York State Office of Parks, Recreation, and Historic Preservation, The Palisades Interstate Park Commission, their commissioners, officers, agents and employees.
- 12) The permittee must be responsible for personal injury, including death, and all property damage due to it activities and indemnifies and holds harmless the People of the State of New York, the New York State Executive Department, the New York State Office of Parks, Recreation, and Historic Preservation, The Palisades Interstate Park Commission, their commissioners, officers, agents and employees.
- 13) This permit can be revoked at any time for noncompliance with the terms and conditions indicated.
- 14) This permit cannot be sold, transferred or reissued.
- 15) This permit is not valid until it has been signed by both parties.
